DR. HARRY M. ZWEIG MEMORIAL TROT NO. 37 For 3-Year-Old Trotters in 2011 (Foals of 2008) OPEN TO THE WORLD *(Supplemental)

To Be Raced As: 3-Year-Old Trotters in 2011 (Foals of 2008)

To Be Raced At: Tioga Downs

Estimated Purse: \$400,000 with Filly division

Nomination Fee: \$50.00 on May 15, 2009 for Colts & Geldings

\$25.00 on May 15, 2009 for Fillies

Future Payments:

2-Year-Old Continuation Fee—March 15, 2010

\$300.00—*Colts & Geldings* \$150.00—*Fillies*

3-Year-Old Sustaining Fee—February 15, 2011

\$400.00—*Colts & Geldings* \$200.00—*Fillies*

3-Year-Old Sustaining Fee—April 15, 2011

\$500.00—*Colts & Geldings* \$250.00—*Fillies*

***Supplementary Payments:** Supplementary entries will be accepted at time of declaration by payment of \$20,000 for the open division and \$5,000 for the filly division, not including starting fee due on all starters. All supplementary payments will be added to the total purse for each sex.

Declaration Fee: \$2,500 for the open division, \$1,000 for the filly division. Must accompany declaration to start. All declaration fees will be added to the purse.

Added Money: The sponsor of this race will add a minimum of \$50,000 to the monies paid in by the horsemen for the open division and \$25,000 to the filly division, barring any unforeseen circumstances which may preclude this. If a larger sum will be added to the event, it will be announced before the first three-year-old payment.

Conditions and Rules: For purposes of declarations, the horse must have at least one charted satisfactory performance line within 30 days of the day of declaration with a time of 2:04 or better. Race to be run under the management of the Harness Horse Breeders of New York State, Inc. Conditions subject to approval by the New York State Racing and Wagering Board, Division of Harness Racing. Race will be governed by the rules of the Commission and track where raced.

Declarations close at the time announced by the host track.

Race to be one dash at a mile. If more than eleven (11) declare to start, the event may be split into divisions under any method current in the rules and regulations. Harness Horse Breeders and the host track reserve the right to race eliminations, if necessary, either the same day as the final or the previous week, should it be deemed suitable for the event and will be announced before the first three-year-old payment.

Should circumstances prevent the racing of this event, monies paid in will be pro-rated among the owners of remaining eligibles of the uncontested race at the time of cancellation.

Filly Division: Dr. Harry M. Zweig Memorial Trot provides for a filly division. All monies will follow horse by sex. Fillies may start in the Open Division by payment of the declaration fee (\$2,500.00) or supplemental declaration fee (\$20,000.00) plus declaration fee, but may not start in both divisions.

Purse Distribution:

Five or more starters: 50% 25% 12% 8% 5%

Four starters: 50% 25% 15% 10%

Three starters: 60% 30% 10%

Two starters: 65% 35%
